Although the International Co-Prosecutor considers recording this disagreement is not necessary for the filing to be valid, it nonetheless has been recorded in a register of disagreements kept by the Greffier of the Co-Prosecutors to ensure it is in compliance with the Co-Investigating Judges' "Decision on time extension request and investigative requests by the International Co-Prosecutor regarding Case 003", dated 7 June 2011 (D20/3). The 7 June 2011 decision is also the subject of an appeal pending before the Pre-Trial Chamber.
