**THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal"),

**RECALLING** the "Decision on Accused's Motion to Subpoena Slavko Puhalić", issued on 20 March 2013 ("Decision"), in which the Chamber granted the Accused's motion filed on 1 March 2013, requesting that a subpoena be issued directing Slavko Puhalić ("Witness") to appear before the Chamber to give oral testimony on 7 May 2013;

**RECALLING** further that the subpoena *ad testificandum* issued on 20 March 2013 ("Subpoena") which ordered the Witness to appear at the seat of the Tribunal on 7 May 2013 was subsequently amended orally such that the Witness was ordered to appear on 30 August 2013:<sup>1</sup>

**NOTING** the Accused's "Submission on Scheduling of Defence Witnesses", filed publicly with a confidential annex on 7 August 2013 ("Motion"), in which the Accused requests, *inter alia*, that the date of the Witness's testimony be postponed to 27 November 2013;<sup>2</sup>

**CONSIDERING** that the Witness was informed that the date of his testimony was subject to change and that the Subpoena would remain in force notwithstanding any such change;<sup>3</sup>
