## Re-Disclosure of Incriminatory Evidence to the Defence


The Office of the Prosecutor ("Prosecution") herewith notifies the Single Judge that on 23 June 2008 it re-disclosed a document that had previously been provided to the Defence teams of Germain KATANGA and Mathieu NGUDJOLO CHUI,<sup>1</sup> with the eCourt metadata fields linked to the image of the CD containing the document, as found in the Prosecution Ringtail system. The content of the CD provided to the Defence, due to its size, could not be uploaded into Ringtail. The eCourt metadata has thus been tagged to the image of the cover of the CD itself and not to its content.

### Communication of Original to the Registry

The original CD provided to the Registry contains the full imagery of the document, the copy of which was provided to the Defence in April 2008.
